

Clerk's Minutes

July 14, 2025

The meeting and was called to order at 6 P.M. Present were Supervisors: Jan Proffit, Brent Hodgeman, Darrick Sweats and Clerk, Cheryl Wickham.

Guests were: Bob Brewster, Claudia Johnson, Glen Sladik, Larry Pluta, Jennifer Elliott Todd Johnson and Walt Hodgeman. Duxbury Fire Chief, Mike Mc Cullen also attended.

The meeting was called to order by Chairperson, Brent Hodgeman and the Pledge to the Flag was recited.

The Agenda was reviewed by the Town Board and a motion was made by Brent and 2nd by Jan to approve. All Yay and motion carried and the meeting continued.

Open Forum was conducted as follows:

Todd Johnson asked again about spending money on Lawyers. The Board tried to explain that some issues need to be done legally by a lawyer.

Walt Hodgeman said the Well at the Fire Hall is not working and to get it replaced or repaired. Brent said he would make a motion to spend up to \$500.00 on it and Darrick 2nd that motion and all yay and motion approved.

Bob Brewster said that Fornengo has obstructed the ditch on Witt Road and said Arna has a notice on the Board stating there needs to be a \$500.00 deposit, before any road work is done.

The Board had received a copy of the minutes for the June meeting and a motion was made by Jan and 2nd by Darrick to approve. All yay and motion carried.

The Financial Report was read and a motion was made by Brent and 2nd by Jan to approve. All yay and motion carried.

Bills were read and a motion was made by Brent and 2nd by Jan to pay them. All yay and motion carried.

Correspondence was read and discussed.

Brent said he is still checking out what other cemeteries are charging for their services.

Bob said the Planning Commission and the Town Board met again resuming their recessed meeting from July 2nd and Bob read the Planning Commission suggested changes and comments regarding the new Ordinance. He said Draft 3 should be ready by July 28, 2025. The draft will be printed in red all of the changes.

The Fire Chief, Mike spoke and said they are going to raise the price of fire protection this year to \$7,500.00 and next year it will go up to \$10,000.00. He explained the purpose of the fire department is not only for fires, but for any disasters, like the one Markville had in 2011.

Darrick made a motion and Jan 2nd it for Doug to have 5 loads of gravel put on Condor Road as soon as possible and for Doug to contact Summerland to start on the roads. All yay and motion carried.

Brent said he has contacted a realtor regarding the old Bluhm property but has not heard back from him.

We are looking into ways to solicit donations for the use of the property at the Flowage. Brent is still researching the options.

Brent is looking into a possible CD for our Grader Fund money. Jan said we should leave it here, because it is used for repairs on the Grader.

Motion made by Brent and 2nd by Darrick to adjourn. All yay and meeting adjourned at 7:15 PM.
